#### PLEDGE OF ALLEGIANCE

Mayor Jim Collins asked Lynette Wolf to lead the group in the Pledge of Allegiance.

APPROVAL OF THE CONSENT AGENDA

Councilman David Armstrong moved, Councilwoman Cassandra Siefkas seconded to approve the consent agenda along with the minutes of the September 08, 2020 Regular City Council meeting and the Special Call meeting of September 29, 2020 and the September vouchers. On a voice vote, Mayor Jim Collins declared the Motion carried.

Councilman David Armstrong moved, Councilwoman Cassandra Siefkas seconded to amend the document misspelling of Cassandra Torrez-Siefkas to Cassandra Torres-Siefkas. On a voice Vote, Mayor Jim Collins declared the Motion carried.

**CITIZEN PARTICIPATION:** a. Sammie George, Bent County Development Foundation and Todd Horning, Prospective Business Owner

Sammie George the Bent County Development Foundation Director introduced Todd Horning to the Mayor and City Councilors. Mr. Horning introduced himself and informed the Councilors that they would like to purchase a ranch outside of Las Animas to build a world class shooting facility. Mr. Horning stated that this would be a large investment that would benefit the community. Mr. Horning stated that other businesses could benefit from the shooting complex. They are applying for a special review permit from Bent County. The sale of the property is contingent upon getting the permit from the County. Mr. Horning asked for the support of the Mayor and City Council.

### b. Rick Rigel, ARPA General Manager

Mayor Collins recognized Rick Rigel the ARPA General Manager. Mr. Rigel supplied information to the Mayor and City Councilors providing an update. Mr. Rigel gave an overview of the organization for the new City Councilors. The packet contained information on rates and electric sales. Mr. Rigel also discussed the demolition of the Lamar power plant. The project should be completed by March of 2021. A budget for ARPA was also enclosed in the packet. Mr. Rigel also discussed the shift to renewable energy.

### PUBLIC WORKS BOARD REPORT

Upon recommendation from the Public Works Board, Councilwoman Cassandra Siefkas moved to appoint Rose Prichard to the Public Works Board. On a voice vote, Mayor Jim Collins declared the Motion carried.

Mayor Jim Collins recognized Rose Prichard. Ms. Richard thanked the Council for appointing her to the Public Works Board. Ms. Prichard asked the Council if a mercury vapor light could be installed in the darkest part of the park for security purposes. Mayor Collins stated that it would be added to the November Agenda for action.

Upon recommendation from the Public Works Board, Councilwoman Cassandra Siefkas moved to forgive the surcharge amount for leaks in the amount of \$36.88 for Luis Carrillo at 1013 Maple Ave. On a voice vote, Mayor Jim Collins declared the Motion carried.

### APPOINTMENT OF TERRY KIM TO THE PUBLIC WORKS BOARD
