POSSIBLE ACTION ON BALLOT QUESTION FOR THE MARIJUANA MORATORIUM

Councilwoman Cassandra Siefkas moved, Councilman Troy Abdulla seconded to reject RESOLUTION NO. 4-20, A RESOLUTION OF THE CITY OF LAS ANIMAS, COLORADO, AUTHORIZING THE SUBMISSION OF A BALLOT QUESTION TO THE VOTERS OF THE CITY OF LAS ANIMAS, COLORADO CONCERNING THE EXTENTION OF A MORATORIUM ON THE SUBMISSION, ACCEPTANCE, PROCESSING, AND APPROVAL OF ANY NEW LICENSE APPLICATION FOR ALL RETAIL MARIJUANA AND MEDICAL MARIJUANA FACILITIES IN THE CITY OF LAS ANIMAS; SAID BALLOT QUESTION TO BE SUBMITTED AT THE GENERAL ELECTION TO BE HELD NOVEMBER 3, 2020; PRESCRIBING THE FORM OF BALLOT QUESTION FOR SUBMISSION AT SAID ELECTION; AND PROVIDING FOR CERTIFICATION OF THE ELECTION QUESTION TO THE COUNTY CLERK AND RECORDER; AND OTHERWISE PROVIDING FOR THE CONDUCT THEREOF and not have the Ballot question placed on the November 3, 2020 ballot. On a voice vote, with Councilman Robert Smith voting no, Mayor Jim Collins declared the Motion carried.
